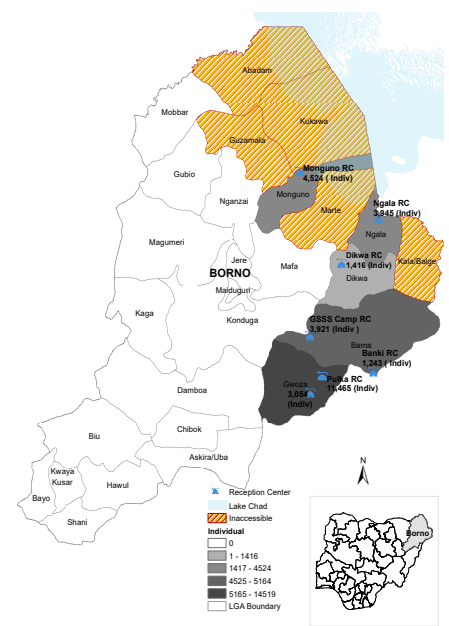
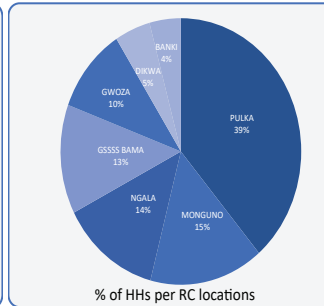
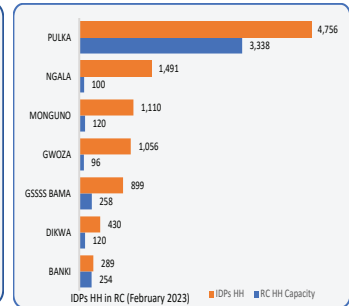
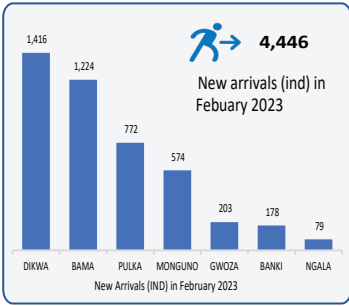


The seven active reception centres in Borno State recorded an overwhelming number of new arrivals, mainly operating over their carrying capacity in February 2023. In most cases, the IDPs overstayed (over 72 hours) at the reception centres, with some sleeping outside or in overcrowded spaces. In February 2023, 29,568 individuals were recorded in all 7 RCs, with 59% of the total number are children up to 17 years. 1,468 families 4,446 (individuals) of new arrivals were registered in all active Receptioncentres across 5 LGAs (Bama, Dikwa, gwoza, Monguno and Ngala) in Borno state. Out of 10,031 families only 5,716 benefitted from in kind food distribution.

In comparison to all the RCs Gwoza hosts the highest numbers of IDPs in reception centres with Pulka ward accomodating 4,756 families with 11,465 individuals while a further 1,056 families with 3,054 individuals have taken shelter in the Gwoza RC. In Ngala there are 1,491 families with 3,945 individuals are living in the highly congested RC with a capacity of 100 families. To ease the burden of the new arrivals, some have been referred to relatives in the camps and host community causing more protection risks.

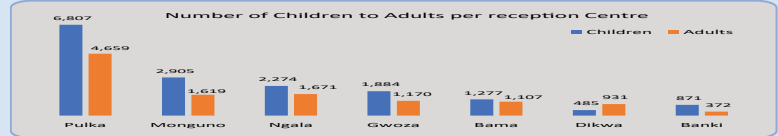

HUMANITARIAN RESPONSE AND GAPS

SHELTER ACTIVE SERVICES

Shelter services include shelter construction, reinforcement, shelter kit distribution and shelter repair.

GAPS

In Banki, 55 HHs are sleeping in the open space. There is urgent need of shelter in Banki 55 HHs, Dikwa 430 HHs and Ngala 1419 HHs, Dikwa.

NFI NON-FOOD ITEMS (NFI)

ACTIVE SERVICES

NFI services include the distribution of NFI kits (Standard/Improved).

GAPS

1,045 HHs in Monguno is in need of NFIs. NFIs needs; 683 HHs in Ngala, 582 HHs in Gwoza, 485 HHs in Bama, 430 HHs in Dikwa, 245 HHs in Pulka, and 95 HHs in Pulka. Most needed NFIs are Blanket mats, Kitchen item and sheeting.

CAMP COORD. AND CAMP MANAGEMENT ACTIVE SERVICES

CCCM services includes registration, sensitization, sanitation, shelter allocation, service/intervention advocacy, coordination meetings, referrals and complaints and feedback mechanism.

GAPS

The CCCM partners in Pulka are raising concerns of over congestion of the RC.

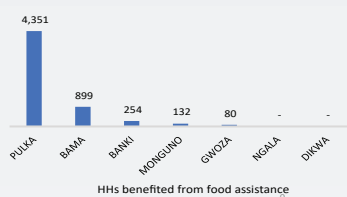
FOOD SECURITY (FS)

ACTIVE SERVICES

FS services include wet feeding, general food distribution and cash based transfer.

GAPS

New arrival from Dikwa 430 HHs (1416 Individuals) and Ngala 30 HHs (70 Individuals) have not benefited with food interventions and need urgent response. In other RCs some beneficiaries are not benefiting from partners due to lack of scope cards.



NUTRITION ACTIVE SERVICES

Supplementary Feeding for children, malnourished children, pregnant and lactating mothers, and Screening for malnourished children.

GAPS

There are cases of malnutrition observed in Banki, Bama and Ngala. In Ngala there have not been enrolled into the nutrition program.

HEALTH ACTIVE SERVICES

Medical screening, referrals, vaccination, immunization, distribution of essential medicine in all RCs.

GAPS

No functional primary health care available in Ngala RC's. There is need for secondary health care in Bama, Banki, Dikwa, Pulka, Gwoza, Monguno and Ngala.

PROTECTION ACTIVE SERVICES

Protection services include Legal Documentation, Gender Based Violence (GBV) services, general protection services, referrals, vulnerability screening, child protection services and mental health and psychosocial support (MHPSS) services.

GAPS

GBV activities including Legal assistance, MHPSS services needed in Bama, Ngala, and Dikwa. There is need of GBV partner in Ngala.

WATER, SANITATION AND HYGIENE (WASH) ACTIVE SERVICES

WASH services include construction of latrines and showers, distribution of sanitation materials, dislodgement of latrines/solid waste, chlorination of water, hygiene promotion and maintenance of WASH facilities.

GAPS

In Bama, Gwoza and Pulka there is urgent need of lighting around the latrine at night. There are 4 damaged latrines in Bama. There are needs of WASH activities for new arrivals at Bama. In Ngala there is urgent need to upgrade water source.
