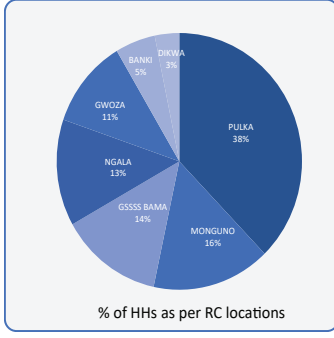
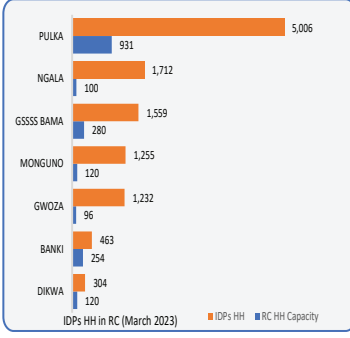
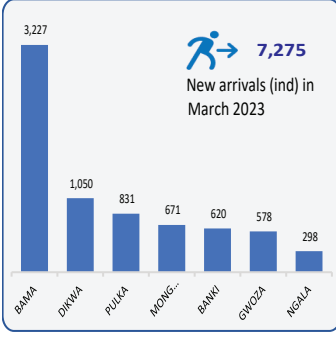
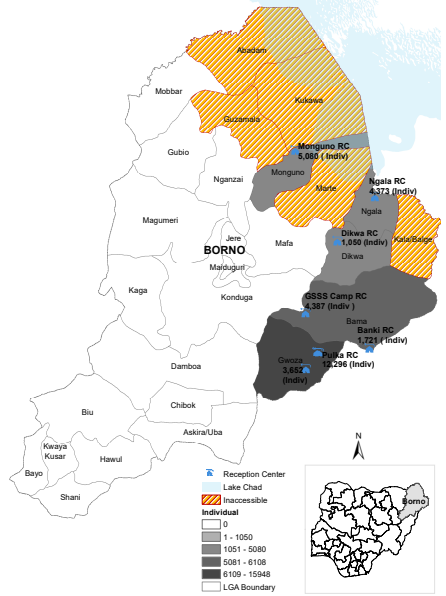




In March 2023, 32,559 individuals were recorded in all 7 RCs, with 60% of the total number are children up to 17 years. 2,391 families 7,275 (individuals) of new arrivals were registered in all active Reception centres across 5 LGAs (Bama, Dikwa, Gwoza, Monguno and Ngala) in Borno state which has been increased by 63% HHs as compare to February HHs. Out of 11,531 families only 6,234 benefitted from in kind food distribution in Banki, Bama, Gwoza and Pulka Reception Centres. There is need to have the biometric registration for the new arrivals before been register by the ETT team. In comparison to all the RCs Gwoza hosts the highest numbers of IDPs in reception centres with Pulka ward accomodating 5,006 families with 12,296 individuals while a further 1,232 families with 3,652 individuals have taken shelter in the Gwoza RC. As much as efforts of decongestion are still ongoing, the situation on ground calls for concerted efforts by all stakeholders to ensure improved living conditions of those affected and received across all the 7 RCs. In Ngala there are 1,712 families with 4,373 individuals are living in the highly congested RC with a capacity of 100 families.

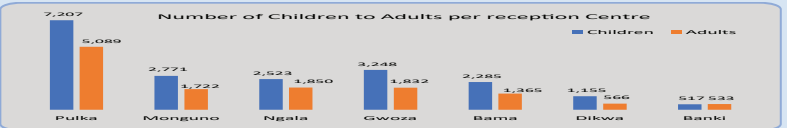

HUMANITARIAN RESPONSE AND GAPS

SHELTER ACTIVE SERVICES

Shelter services include shelter construction, reinforcement, shelter kit distribution and shelter repair.

GAPS

There is need of shelter for 751 HHs in Monguno, 387 in HHs Pulka, 304 HHs in Dikwa, 145 HHs in Gwoza, 55 HHs in Banki and 5 HHs in Bama for a new arrivals influx.

NFI NON-FOOD ITEMS (NFI) ACTIVE SERVICES

NFI services include the distribution of NFI kits (Standard/Improved).

GAPS

1,559 HHs in Bama is in need of NFIs. NFIs needs; 1,123 HHs in Monguno, 824 HHs in Ngala, 653 HHs in Gwoza, 420 HHs in Pulka, 304 HHs in Dikwa, and 209 HHs in Banki. There is need of NFI items for a new arrival influx. Most needs items are Blanket mats and Kitchen items.

CAMP COORD. AND CAMP MANAGEMENT ACTIVE SERVICES

CCCM services includes registration, sensitization, sanitation, shelter allocation, service/intervention advocacy, coordination meetings, referrals and complaints and feedback mechanism.

GAPS

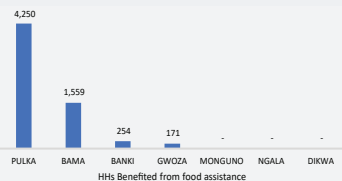
The CCCM partners in Bama are raising concerns of over congestion of the RC.

FOOD SECURITY (FS) ACTIVE SERVICES

FS services include wet feeding, general food distribution and cash based transfer.

GAPS

180 HHs (392 Individuals) in Ngala, 1,484 HHs (4,017 Individuals) in Pulka, and 304 HHs (912 Individuals) in Dikwa are in urgent need for food interventions for new arrival influx. In Ngala there is absence of active wet feeding partners at the reception centre from December 2022.



NUTRITION ACTIVE SERVICES

Supplementary Feeding for children, malnourished children, pregnant and lactating mothers, and Screening for malnourished children.

GAPS

There are cases of malnutrition observed in Banki, Bama and Ngala. In Ngala, there is need to enrolled into the nutrition program for new arrivals influx.

HEALTH ACTIVE SERVICES

Medical screening, referrals, vaccination, immunization, distribution of essential medicine in all RCs.

GAPS

No functional primary health care available in Ngala and Monguno RC's. There is need for secondary helath care in Bama, Banki, Dikwa, Pulka, Gwoza, Monguno and Ngala.

PROTECTION ACTIVE SERVICES

Protection services include Legal Documentation, Gender Based Violence (GBV) services, general protection services, referrals, vulnerability screening, child protection services and mental health and pschosocial support (MHPSS) services.

GAPS

Legal assistance services needed in Bama, Ngala, Pulka and Dikwa. GBV partner needed in Ngala.

WATER, SANITATION AND HYGIENE (WASH) ACTIVE SERVICES

WASH services include construction of latrines and showers, distribution of sanitation materials, dislodgement of latrines/solid waste, chlorination of water, hygiene promotion and maintenance of WASH facilities.

GAPS

In Bama, Gwoza and Pulka there is urgent need of lighting around the latrine at night. There are 4 damaged latrines in Bama. There are needs of WASH activities for new arrivals at Bama. In Ngala there is urgent need to upgrade water source.
