Reception centres Capacity (HHs)






The CCCM, Shelter, and NFI sector present service monitoring and gap analysis for seven reception centres: Bama, Banki, Monguno, Pulka, Dikwa, Ngala, and Gwoza in Borno State. This report provides humanitarian partners with timely information to track humanitarian responses, identify sectoral gaps, and respond to displaced populations' needs.


#### **KEY HIGHLIGHTS**

In October 2023, 23,584 individuals representing 8,204 households (HHs) were recorded in seven reception centres in Borno State, with women and children accounting for 89 percent of the total. In this reporting period, 6 HHs (13 individuals), for relocation to other area, and family reunification, departed from Banki, Gwoza and Pulka reception centres.

# NUTRITION

#### **ACTIVE SERVICES**

Supplementary feeding for children, malnourished children, pregnant and lactating mothers, and Screening for malnourished children.

#### GAPS

CCCM partners reported 35 malnutrition cases in Monguno (23), Bama (8), Dikwa (3)and Ngala (1) reception centers. There is a need for more supplementary feeding for pregnant and lactating mothers in Banki, Bama, Gwoza, Ngala, Pulka and Dikwa,

### **HUMANITARIAN RESPONSE AND GAP**

# **(計) SHELTER**

#### **ACTIVE SERVICES**

Shelter services include shelter construction, reinforcement, shelter kit distribution and shelter repair.

## **GAPS**

A total of 2,629 HHs urgently need shelter responses in the seven reception centres where 318 HHs were recorded living outside, while 357 HHs were referred for sharing modalities. There is a need for more shelters to accommodate 2,063 HHs living in temporary settlements.

# THEALTH

### **ACTIVE SERVICES**

Medical screening, referrals, vaccination, immunization, distribution of essential medicine in all RCs.

There is need of functional primary health care in Ngala and Dikwa reception centres and secondary health care in Banki, Bama, Monguno, Pulka and Ngala.

# NE NON-FOOD ITEMS (NFI)

## **ACTIVE SERVICES**

NFI services include the distribution of NFI kits (Standard/Improved).

#### **GAPS**

A tolal of 2,064 HHs need for NFI intervention in Pukla (1,450 HHs), Bama (265 HHs), Ngala (169 HHs), Monguno (112 HHs), Gwoza (45 HHs) and Dikwa (23 HHs). They are in need of blanket mats, Kitchen sets, bucket/Jerrycan, mosquito nets, sheeting and soap.

# CAMP COORD. AND CAMP MANAGEMENT

# **ACTIVE SERVICES**

CCCM services include registration, site service coordination and monitoring, reception centre management, awareness/sensitization, service advocacy, referrals and complaints, and feedback mechanism.

#### **GAPS**

The CCCM partners mentioned that all the seven receeption centres are congested. Accomodation for the new arrivals are the major challenges in the reception centre. There are lack of food assistance support in Gwoza, Pulka and Dikwa. In Bama, there is need of fuel efficient stove for new arrivals.

# PROTECTION

### **ACTIVE SERVICES**

Protection services include Legal Documentation, Gender Based Violence (GBV) services, general protection services, referrals, vulnerability screening, child protection services and mental health and pschosocial support (MHPSS) services.

There are need for legal aid on protection concerns in Monguno, Ngala, Pulka and Dikwa. Also, CCCM partners noted the lack of MHPSS services in Pulka and Dikwa.

# WATER, SANITATION AND HYGIENE (WASH)

**ACTIVE SERVICES**WASH services include construction of latrines and showers, distribution of sanitation materials, dislodgement of latrines/solid waste management, chlorination of water, hygiene promotion and maintenance of WASH facilities.

#### GAPS

A total of 15 showers were damanged in Monguno (7) and Pulka (8) and 14 latrines are damaged in Bama (2), Gwoza (2) and Pulka (10) and Dikwa (4). There are lack of lighting around the latrines in Bama, Pulka and Dikwa poses a protection risk to the IDPs. In Nagla and Pulka, there is need of more water supply trhrough water tanker due to lack of borehole.

## FOOD SECURITY (FS)

# **ACTIVE SERVICES**

Food security services include wet feeding, general food distribution and cash based transfer.

#### GAPS

A total of 575 HHs received in-kind food distribution across the seven reception centres during this period. CCCM partners observed there is urgent need of food assistance

in Bama and Gwoza reception centre. In Pulka, due to scale down by WFP, new arrivals onsite

have no access to food assistance which made them to escaped back to bush for survival while others to neighbouring state of Adamawa State.
