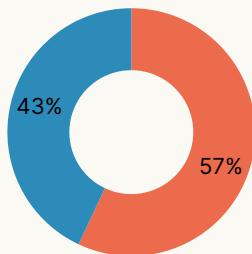
## GAZA RESPONSE

1 February 2025

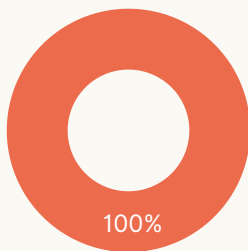
### GENERAL INFORMATION

- Assessment covers **31,867 individuals** and **6,451 households** living in 14 sites, including 8 makeshift sites, and 6 UNRWA collective centers in the governorates of Khan Younis (71%), Deir al Balah (14%), and Rafah (14%).
- In all the assessed sites (14 sites) KIs reported people are leaving the site.
- On average, KIs reported 1,300 individuals leaving each site. An increase from the average reported yesterday and previous days.

- Sites with population leaving

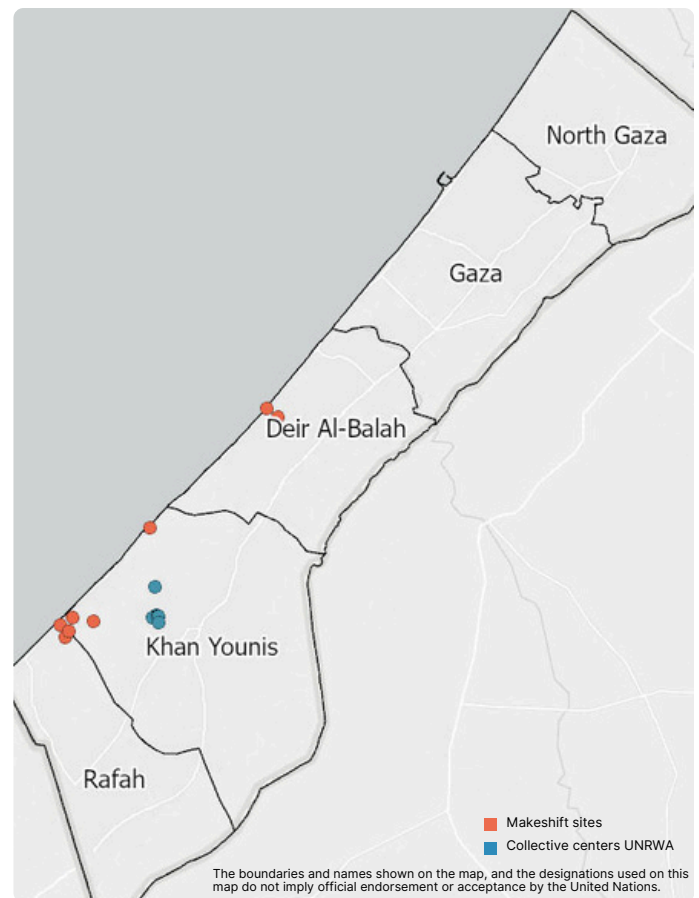

#### METHODOLOGY:

SMC partners (NRC, UNRWA, ACTED, PARC/DRC, PHC) collected information using a structured questionnaire hosted on Zite Manager. Enumerators contacted focal points (KIs) by phone calls, recording the information directly on the questionnaire online.

Calls were conducted daily during the ceasefire, the information on this report was collected between **2pm on January 30th and 2pm on February 1st**. Cumulative findings of the site to site assessment can be consulted on the [interactive dashboard](#).

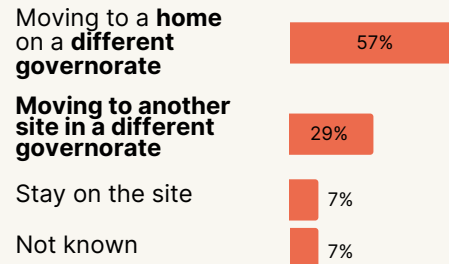

## MOVEMENT INTENTIONS

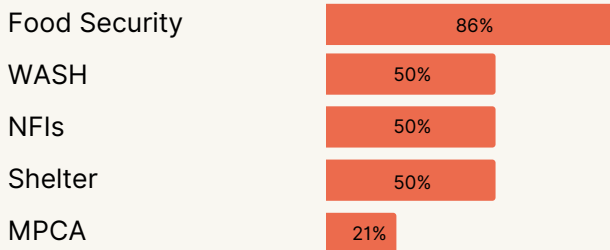
- In the majority of the sites (86%), KIs reported people were planning to move to a different governorate, to their own house or relatives' house (57%) to another site (29%).
- In a minority of the sites assessed, KIs reported the people will stay at the site (7%) or people do not know what they will do (7%).
- On sites where people reported intentions to leave, KIs reported either half (reported by 29% of KIs) or few of the people at the site (21%) will move out of the site. 21% of KIs also reported not knowing the proportion of the population that will move out
- The most reported governorates where people will be moving to were North Gaza (reported by KIs in 64% of the sites), Gaza (45%), Khan Younis (43%), and Rafah (29%).\*

## KEY POPULATION NEEDS

Most reported **sectors with need of humanitarian assistance** are:\*



- In the Food Security sector, the most needed assistance was reportedly food vouchers or cash transfers (71%), and in kind food distributions (64%).\*
- In WASH sector the most needed assistance was reportedly drinking water (50%), hygiene kits (36%), water for domestic use (21%), and sanitation services (14%).\*
- The most needed NFIs were: blankets and mats (43%), emergency shelter items (36%), clothing (14%), winterization items (14%) and kitchen items (14%) as reported by KIs.\*
- Among shelter needs reported, protection against weather (43%), need for shelters (36%) and lighting (29%) were the most reported.\*

## HUMANITARIAN ASSISTANCE RECEIVED

- In all assessed sites (100%, 14 sites), KIs reported no humanitarian assistance had been received in the past 7 days.
